

Offer the Credit Card Payment Option to your Borrowers

Campus Partners now offers our customers the option to allow their borrowers to make credit card payments through mycampusloan.com! This new payment method is being offered in addition to several other electronic payment options available to your borrower, such as AutoDraft, E-Pay, and Pay-by-Phone. By providing your borrowers a variety of payment choices, the probability of prompt, current payments is increased, keeping your borrowers out of default and money being returned to your revolving loan fund. The credit card option can also be used as a method for your borrowers to make emergency payments so their payment arrives on time, avoiding late charges and negative credit reporting.

If you decide offering the credit card payment option is right for your borrowers, here's what you need to do to sign up:

- Download the Credit Card Authorization Transaction form from campuspartners.com
- Decide how you would like the processing fee assigned:

There are two options available:

- 1) The school can absorb the 3% processing fee (Mastercard, Visa, and Discover Cards accepted)
- 2) The school can pass the 3% processing fee to the borrower (Mastercard and Discover accepted)
- Determine if you would like the special message printed on your borrower statements
- Sign the form and return to Campus Partners

It's that simple!

Once your Authorization Form is processed, your borrowers will begin to see the Credit Card payment option under the Pay My Loan selection on mycampusloan.com.



If you decide that you do not want to offer this option to your borrowers, you do not have to do a thing. The decision is totally up to you. Schools must complete an Authorization Form in order to take advantage of this new payment method.

With Campus Partners, you don't have to worry about the safety of your borrowers' information!

Security is always our primary concern and you can be assured that Campus Partners procedures are in compliance with stringent Payment Card Industry (PCI) standards, ensuring each transaction is as safe as possible. We <u>never</u> store your borrowers' credit card information on our Web site or System III. Once the payment has processed, all information is deleted!
